
1. As regard to the information/document sought under Para (1) of your above mentioned application, it is informed that the said information/document is an information given/available under the fiduciary capacity. In view of the same, we regret to inform that we would not be able to share the said information/document with you on account of the exemption from disclosure of information as provided under the Section 8(1)(e) of RTI Act.
2. As regard to the information sought under Para (2) of your above mentioned application, it is informed that the said information is of commercial confidence (*which could harm the competitive position of third parties*) and is an information given/available under the fiduciary capacity. In view of the same, we regret to inform that we would not be able to share the said information with you on account of the exemption from disclosure of information as provided under the RTI Act.

In the event, you are not satisfied with the decision of the below mentioned Chief Public Information Officer (CPIO), you may prefer an appeal to the first appellate authority in our organisation, within 30 (thirty) days of receipt of this letter, at the following address:
